The State Board of Technical Education and Training, Andhra Pradesh, Mangalagiri is inviting applications from Government Polytechnics / Private Institutions / Organizations for grant of Affiliation to offer the following Certificate Courses in Computers (CCIC) /Craft /Land Surveying for the Academic Year 2023 -24, on self-financed mode as per norms of SBTE&T, Andhra Pradesh.

The State Board of Technical Education and Training, Andhra Pradesh introduced the Certificate Courses based on the request of the Private Organizations / Institutions to encourage the unemployed youth, dropouts, house wives and who would like to learn a skill to make a living.

The grant of affiliations of the courses will be accorded subject to fulfillment of norms & standards of the State Board of Technical Education and Training, AP, Mangalagiri and also the conditions as mentioned below for the courses & intake.

- 1. The institution should be run by a registered society / organization. The management of society/ institution shall have an irrevocable resolution to establish and run the proposed institution for a minimum of two (2) years. Any change in the management structure / office bearers shall be informed to the SBTE&T, Andhra Pradesh.
- 2. The institution has to pay prescribed affiliation fee for each course in every academic year before the stipulated last date along with fresh application in the prescribed Proforma.
- 3. The Affiliation to be granted is for coaching, training the candidates for examination of certificate courses only conducted by SBTE&T, A.P for the academic year in question.
- 4. The institute should not use the affiliation of the course accorded by SBTE&T, A.P, for the other courses conducted by the institute on its own.
- a) A minimum of **10 (Ten) candidates** for each course for each batch should be admitted by the institution, otherwise the institution cannot be granted affiliation.
- b) The admission process is at the institution level. The institution should follow the Rule of Reservation while giving due importance to the merit.
- c) The Bio-data of the admitted candidates should be uploaded in the SBTE&T Portal 10 days after commencement of the class work or as per the instructions of SBTE&T, A.P, from time to time. These uploaded candidates are only eligible for payment of examination fee.

- d) The admission of students should be made on first come first service, while fulfilling the minimum eligibility/qualification criteria as per SBTE&T, A.P. norms.
- e) The affiliation will be given once in a year i.e., for the year 2023-24. Under any circumstances the intake will not be enhanced in the middle of the year.
- 5. The syllabus of State Board of Technical Education and Training, Andhra Pradesh, Mangalagiri is to be followed.
- 6. The SBTE&T, A.P, Mangalagiri can visit the institute at any time on any working day of academic calendar as per schedule. Any deviation/irregularities reported during such visits on the part of institution/society in any courses approved by this order attract de-affiliation with immediate effect.
- 7. a) The institution should sponsor at least 80% of candidates for the **Examination** per course for the intake sanctioned.
 - b) If the failure of candidates in the end examination is more than **50% of approved intake in successive end examinations** attracts de-affiliation of the institution.
- 8. In case an institution fails to get the renewal of affiliation done for any course in a particular year, the next year it has to apply as a new institution.
- 9. The institution should obtain prior approval of the State Board of Technical Education and Training, A.P for the change in address /change of title /change of name of the institution, if any.
- 10. The institutions are not entitled to use the name/logo of SBTE&T, A.P, in any manner, reflecting/communicating the sense as the institution is recognized by/affiliated to SBTE&T, A.P / Department of Technical Education. However it is restricted to make use to the extent of courses affiliated by SBTE&T, by this order.
- 11. Any sort of misuse of affiliation accorded by State Board of Technical Education and Training, A.P in any manner shall entitle for withdrawal of affiliation & legal action.
- 12. Adequate safety measures for students & faculty regarding building & laboratories should be taken by the institution itself and State Board of Technical Education and Training, A.P, Mangalagiri is no way responsible for any lapse in this regard.
- 13. As per 41st Board Meeting, SBTE&T, A.P will not recommend for reimbursement of tuition fee and any other fee, since the course is meant for working/unemployed youth under self-financed mode.
- 14. The Secretary, State Board of Technical Education and Training, Andhra Pradesh, Mangalagiri reserves the right for withdrawal of temporary affiliation accorded for violation of rules and regulations prescribed or to be prescribed there of as the case may be, at any time.



GUIDELINES FOR ISSUING AFFILIATION TO INSTITUTIONS FOR CONDUCTING CERTIFICATE COURSES IN COMPUTERS(CCIC)/CRAFT/LAND SURVEYING OFFERED BY SBTET, AP MANGALAGIRI FROM THE ACADEMIC YEAR 2023-24 ONWARDS

1.Definition:

- a. "Academic year" means Academic Year of the SBTET, AP, Mangalagiri Academic schedule as stipulated by SBTET, AP in Rules and regulations course wise
- b. "Act" means the SBTET, AP, Hyderabad Act- 1982 (Act 1 of 1982, G.O.Ms.No.140, Dated. 24/4/ 1984.) The Board had come into existence from 1st June' 1984.
- c. "SBTET,AP, Mangalagiri web-portal" means web site hosted by the Andhra Pradesh State Board of Technical Education and Training: http://sbtetap.gov.in
- d. "Applicant" means an applicant that makes an application to the SBTET, AP for Seeking approval for short term certificate courses under SBTET, AP.
- e. "Architect" means an Architect registered with the Council of Architecture established under the Architect Act 1972.
- f. "SBTET" AP, Mangalagiri means Andhra Pradesh State Board of Technical Education and Training, Under section 3 of the Act.
- g. "Course" means one of the branches of learning in Course for a stipulated period.
- h. 'Batch'means **30 candidates** in each certificate course.
- i. "Head of the Institution" means the Principal or the Director or such other Designation as the executive Head of the institution or the institute is referred.
- j. "Private Institution" means an Institution started by a Society/Trust and does not receive any grant/fund from Central and/or State Government and/or Union Territory Administration for meeting its recurring expenditure.
- k. "Society" means a Society registered under Society Registration Act 1860.
- I. "Trust" means a Trust registered under Charitable Trust Act '1950 or any other relevant act.
- m. "Full Time Course" means the course which is conducted during regular timings of the Institution, ie. 10.00 AM to 4.00 P.M for a stipulated period.
- n. "**Part Time Course**" means the course which is conducted before or after the regular working hours of the institution with a stipulated period

2. General:

- a. The institution should be run by a registered society / organization.
- b. The Management of the Society/Institution shall have an irrevocable resolution to establish and run the proposed institution for a minimum of two (2) years.
- c. Any change in the Management / Office bearers shall be informed to the SBTET, AP.
- d. The institution have to pay prescribed Affiliation fee for each course in every academic year before the stipulated last date along with fresh application in the prescribed Proforma.

- e. The Affiliation to be granted is only for coaching and training the candidates for examination of certificate courses conducted by SBTET for one Academic Year only.
- f. The institute should not use the affiliation of a course accorded by Board, for the other courses conducted by the institute on its own.
- g. Affiliation will not be granted if the admitted strength is less than ten for each course.
 - The SBTET will conduct the certificate courses examinations twice in a year. Every year the session should start from September and February.
 - The admission process is at the institution level. The institution should follow the Rule of Reservation (ROR) during admissions.
 - The admission process should be completed by first week September / February.
 - The class work should commence from the first week of the respective months i.e. first week of September / February.
 - The Bio-data of the admitted candidates should be uploaded in to the SBTET Portal within 10 days after commencement of the class work. The hall tickets for appearing the examination will be issued only to those candidates whose bio-data was uploaded within the stipulated time and after payment of examination fee.
 - Minimum qualification/eligibility criteria are as per SBTET norms and admission of students should be made on first come first serve basis.

h. Syllabus:

- As prescribed by the SBTET, AP.
- The final examination will be of objective type and will be conducted through online/offline at the designated Government Polytechnics. Candidates have to appear for the examination at the designated Government Polytechnics.
- The officials of SBTET, AP, Mangalagiri can visit the institute at any time on any working day during the academic calendar as per schedule. Any deviation/ irregularities reported during such visits, affiliation of the institution/society will be cancelled with immediate effect.
- i. In case an institution fails to get the renewal of affiliation for any course in a particular year, the next year it has to apply as a new institution.
- j. The institution should obtain the prior approval of the State Board of Technical Education and Training, AP, Mangalagiri for the change in address /change of title /change of name of the institution, if any.
- k. The institutions are not entitled to use the name/logo of SBTET, AP, in any manner, reflecting/communicating the sense as the institution is recognized by/affiliated to SBTET, AP/Govt./Department of Technical Education. However it is restricted to make use to the extent of courses affiliated by SBTET, by this order.
- Any sort of misuse of affiliation accorded by State Board of Technical Education and Training in any manner shall entitle for de affiliation & legal action.
- m. Adequate safety measures regarding building & laboratories should be taken by the institution for the safety of students & faculty. State Board of Technical Education and Training, Mangalagiri is not responsible for any lapses in this regard.

- n. As per 41st Board Meeting, Fee Reimbursement is not applicable to the candidates and the SBTET will not recommend to Government for reimbursement of fee and any other fee, since the course is meant for working/ unemployed youth.
- o. The Secretary, State Board of Technical Education and Training, Andhra Pradesh, Mangalagiri reserves the right for withdrawal of temporary affiliation accorded for violation of rules and regulations prescribed or to be prescribed there of as the case may be, at any time.

- i) <u>Issuance of Letter of Internet (LOI):</u>

The letter of Intent will be issued to the applicant societies / Trusts who fulfils all the requirements while submitting the application to the Secretary, State Board of Technical Education and Training, A.P., Mangalagiri for affiliation of their institution for offering certificate courses.

- ii) The Applications with insufficient / incomplete information including supporting material will summarily be rejected.
- B. Issuance of Letter of Approval (LOA):
 After successful submission of application through on line, the SBTET will depute an Expert Committee for physical verification of the facilities / requirements available at the institution. On recommendations of the expert committee the approval of institution will be issued. For all fee details the institutions are requested to go through the **item 7 below**.
- C. Further details can be downloaded from http://sbtetap.gov.in
- D. The decision of the SBTET, AP, Mangalagiri shall be final. Canvassing in any form is strictly prohibited. No correspondence will be entertained in processing of applications.

5. Procedure for grant of Affiliation for Certificate Courses offered by SBTET, AP:

5.1 Eligibility for application and requirements:

The following are eligible for submitting the application to SBTET for running short term certificate courses.

a. The Chairman or Secretary of a registered society, registered under the Registration of Societies Act 1860

OR

b. The Chairman or Secretary of a registered trust, under the Charitable Trusts Act 1950 or any other relevant Acts

OR

c. A trust registered by Central Government or the Government of A.P or by a Society

OR

d. A Trust registered by Central Government or the Government of A.P under Public Private Partnership mode through an officer authorized by the Central Government or the Government of Andhra Pradesh.

The applicant Society / Trust, should be registered, under the Societies Registration Act, the Trusts Act or any similar Act.

5.2 Building:

Building shall be on ownership of institute's society or on lease / rental basis for the period for not less than 2 years & provision of extension for next 2 years by the agreement on Rs.100/- non judicial stamp paper and document should be registered with said area registrar.

The following documents are to be submitted:

- a) Lease Deed made on Rs.100/- non judicial stamp paper along with approved Building plan
- b) Structural Safety Certificate from Structural Engineer who had registered with local Authority (Proof of the Certificate to be submitted)

6. DETAILS OF COURSE / ADMISSION FEE:

- a) For CCIC: The courses are to be run on self-supporting basis. However the SBTET has fixed the course fee as Rs. 6,000/- per each module of CCIC.
- b) For Craft Courses: The SBTET has fixed the course fee to be collected from students for the following craft certificate courses are as follows:

RULES AND REGULATIONS FOR CERTIFICATE COURSE IN LAND SURVEYING

- **1. Duration of the course:** The Certificate course shall extend over a period of 4 months.
- **2. Medium of instruction:** The medium of instruction and examination papers shall be in English.

3. Procedure for admission in to the certificate courses:

Selection of candidates is governed by the rules and regulations laid down in this regard from time to time.

- a) Candidate who can wish to seek admission in "Land Surveying" certificate course must have qualified SSC or 10thPass/Fail/above or its equivalent examination conducted by various competent authorities.
- b) Admissions shall be made purely on merit basis.

Admission process will be conducted at the institution level. After admission, the records pertaining to admission, along with PIN numbers of the candidates must be submitted to the State Board of Technical Education and Training.

4. Number of working days:

- a) The minimum no. of working days-4 months (100 days) with 300 hours of instruction.
- b) The working days in a week shall be form Monday to Saturday.
- c) There shall be 3 hours per day i.e. either morning or evening without detrimental to normal working hours of the institution.
- d) The minimum no. of working days are 100 for this course. If the prescribed minimum is not achieved due to any reason, special arrangement shall be made to conduct classes to cover up the syllabus.

5. Eligibility of attendance to appear for the end examination:

- a) A candidate shall be permitted to appear for the end examination, if he/she has attended minimum **75%** of working days during the course.
- b) Shortage in attendance may be condoned up 10% on medical grounds.

Note:

- 1. SBTET is empowered to reject the incomplete applications without assigning any reasons.
- 2. Registration and Inspection fee once paid will not be refunded or adjusted for the next academic year under any circumstances.
- 3. Application received after the due date will not be considered under any circumstances.
