3. Important Instructions:

- ✓ Admission procedure is through online mode only.
- ✓ Interested candidates has to register, fill the application and pay the registration & processing/counselling fee through online mode only using the url https://apsbtet.in/stpc
- ✓ Eligibility list will be published in the website under notification tab.
- ✓ Incomplete applications and applications with lack of required documents/lack visibility will lead to cancellation of candidature.
- ✓ Candidate should apply for one institute only and has to attend the counselling at the same institution.
- ✓ The candidate should produce all original certificates for verification at the institute concerned and the successful admitted candidates shall pay the prescribed course fee on the same day of certificate verification.
- ✓ Admission will be made strictly on merit, based on marks secured in the qualifying examination, subject to work experience requirements if any.
- ✓ Reservation rules will be followed as per Government of Andhra Pradesh norms.
- ✓ Registration and Processing/Counselling fee once paid shall not be refunded under any circumstance.
- ✓ Experience certificate shall contain the industry registration(GST / CIN/Udyam), Nature and type of organisation with authorised signatory (proforma enclose)

4. Examinations:

Examinations will be conducted in nearby Government Polytechnics only as per the schedule given by SBTET,A.P

5. Fee Structure:

a) Registration & Processing/Counselling fee:

An amount of Rs.400/- (Rupees Four Hundred only) shall be paid through online mode at the time of submission of online application

b) Course fee shall be paid at the institute where candidate got admitted. The course wise fee structure is mentioned in the Annexure-II
